The attached invoice from Al Moscow covers the period January through April, 1962 at the rate of \$1500 per month.

I thought that his Consultant's Fee was being paid on a regular monthly basis, but obviously it has not been. We therefore owe him for the full amount from the first of the year.

Moscow is covered in the budget under Candidate, as Special Assistant, at the monthly rate of \$1500.

The \$2,250 which is due from January 1 through February 15 and is not included in the budget should still be paid, and can be charged against Tour Manager and Aide categories, since no one had been hired to fill either of these positions up to April 15th. The amount not spent, therefore, would total \$3,000 and thus more than cover Moscow's back pay.

Since he has not received any remuneration from us at all, I think it is important that Al's check be sent as soon as possible.

In case he hasn't mentioned it, RN suggests that we should put out to the press etc., as well as to our own people, the Werdel - Warren figures which are indicative of the far right strength within the Republican Party of California.

These should be checked but as I recall

Werdel drew about 40% of the Republican vote. This is the comparison that should be the standard measure against which Shell spoke in the primary; i. e. he certainly should do as well as Werdel, and anything less would be an indication of weakening of far right strength.

Motion Picture Industry Labor

The President of the Pacific Palisades Republican Club, Lewis A. Helms, called me the other day to discuss the problems of the motion picture industry.

Mr. Helms himself is a union member of IATSE Local 728, and of course works all the time with labor people.

He says that the situation of the producing companies making pictures overseas has created a very serious job problem in California within the various unions involved in motion picture production. He sent me the attached chart which shows the trend in studio electricians' employment in Southern California, and it is rather shocking.

He further points out that many members of the unions in foreign countries where these pictures are being produced are Communists -- a much higher proportion than in the United States. He admits that out of the approximately 1200 members of Local 728, there are about 135 Communists.

Helms suggests that we contact Denny Dennison, Business Agent for Local 728, who has a great deal of information on this subject and would be happy to cooperate in providing answers to our questions.

I don't know whether we can do anything with this, but it looks as if it might be a way of getting to the union members.

Dear Mr. Holstrom:

Stan McCaffrey has very kindly sent on to me your letter of April 9th expressing your concern about the remarks Mr. Nixon made in San Francisco April 7th.

We certainly recognize that criticism of law enforcement and crime control in California has a double effect. I am sure you know that Mr. Nixon's criticism is directed very definitely at the state level, the Governor and the Attorney General, and not at the local law enforcement level. He recognizes that an outstanding job is being done in the state by city and county law enforcement officials, but feels that they have not been given the proper support and backing at the state level.

We would be very much interested in your observations and thoughts on this subject since you are obviously one of the most highly qualified men in the state in this particular field. If you would be willing to put any of your thoughts down on paper, I would appreciate hearing from you. If, however, you would prefer to discuss the subject with one of our people, this can certainly be arranged. Please let me know your desires in this regard.
